

Supporting Documents for your Financial Declaration Form

You must submit supporting evidence with your Financial Declaration Form, to show that you have sufficient funding in place to cover the Course Fees for Year 1 of your studies.

The table below indicates the supporting documents that are acceptable, depending on your intended payment method. Please be sure to include all of the required supporting documents when you submit your Financial Declaration Form, as failure to do so will result in a delay with your application.

SCHOLARSHIP	<p>An official award letter (on headed paper) from the scholarship provider, which <u>must confirm</u>:</p> <ul style="list-style-type: none"> • The specific amount of funding that will be provided towards your Year 1 Course Fees • The duration of the scholarship (for courses longer than one year) • The timing of the payment(s), to show that the Year 1 funds will be available by the payment deadline (15 October 2026) • Whether the funds will be paid to you, or directly to Exeter College • The name of the person arranging the payment, their email address, and a (postal) billing address.
FUNDING FROM FAMILY MEMBER(S) or PRIVATE SPONSOR(S)	<p>Please provide both:</p> <ol style="list-style-type: none"> 1) A letter of sponsorship signed and dated by the family member(s) or private sponsor(s). The letter <u>must include the following</u>: <ul style="list-style-type: none"> • The full name of all sponsors, with an address, telephone number, and e-mail address for each • Confirmation of the specific amount of personal funds which will be provided towards your Year 1 Course Fees • Confirmation that the funds will be available to pay your Course Fees by the deadline of 15 October 2026. <p>and:</p> <ol style="list-style-type: none"> 2) A Bank Statement / Savings Certificate stating the full name of your sponsor(s). The statement/certificate <u>must show the following</u>: <ul style="list-style-type: none"> • The full name of relevant sponsor(s) • The date of the statement (which should be within the past month) • The amount of funds available <p>If your sponsor is unable to provide a bank statement or savings certificate, please instead provide a letter from a professional advisor (bank manager, lawyer, or accountant). That letter <u>must</u>:</p> <ul style="list-style-type: none"> • Be on headed paper, with postal address, telephone number and email address stated • Be dated and signed within the past month • Vouch for the ability and willingness of your sponsor(s) to pay the required amount by the deadline of 15 October 2026.

<p>US LOAN or CANADIAN LOAN</p>	<p>An official loan confirmation letter from the US Loans Team of the University.</p> <p>Please see the following information:</p> <p>US Federal Loans: here Canadian Loans: here</p>
<p>BANK or GOVERNMENT LOAN</p> <p>(but <u>not</u> a UK, US, or Canadian Government Loan – for these please see above)</p>	<p>An official loan confirmation letter (<u>not</u> confirmation of your application for the loan).</p> <p>The official loan confirmation letter <u>must be on headed paper and state</u>:</p> <ul style="list-style-type: none"> • The contact details of the loan provider • The amount of the loan that you will receive • The timing of the payment(s), noting that Course Fees are payable <u>in full</u> by the deadline of 15 October 2026 • The currency of the funds (if not GBP)
<p>SELF-FUNDING YOUR STUDIES (SAVINGS)</p>	<p>A Personal Bank Statement / Savings Certificate stating your full name as the sole account holder. This <u>must</u>:</p> <ul style="list-style-type: none"> • Be dated within the past month • Display your full name • Confirm the amount of funds available • Confirm the currency in which the funds are held

Note that all supporting evidence must be provided **in English**. If your original document is in a different language, then please provide an official translation.
